Porsche Macan Giveaway

1. SPONSORS

The Porsche Macan Giveaway (“Sweepstakes”) is sponsored by Community Choice Credit Union (“Sponsor”).

2. ELIGIBILITY

The Sweepstakes is open to legal residents of the State of Iowa who are at least eighteen (18) years of age at the time of entry and who possess a valid Iowa driver’s license at the time of entry and at the time of prize award.

Employees of Sponsor and its respective parents, subsidiaries, affiliates, advertising and promotion agencies, and any other companies associated with the Sweepstakes, as well as members of their immediate families (spouse, parents, children, siblings, and their respective spouses) and individuals living in the same household, are not eligible to enter or win.

The Sweepstakes is subject to all applicable federal, state, and local laws and regulations.

3. AGREEMENT TO OFFICIAL RULES

Participation in the Sweepstakes constitutes entrant’s full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning the Sweepstakes is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein. The Sponsor reserves the right to disqualify a participant if the Sweepstakes rules are violated in any way. 4. SWEEPSTAKES PERIOD

The Sweepstakes begins on May 1st, 2026, and ends on August 31st, 2026. Entries made before or after the official Sweepstakes period will be disqualified. Entries will be accepted for the duration of the Sweepstakes period.

5. HOW TO ENTER

Standard Entry

During the Sweepstakes Period, eligible individuals may enter by visiting www.UNbankingPorsche.com and completing the online entry form, or by submitting a paper entry form at Sponsor-hosted events. Each completed entry form will count as one (1) entry.

Bonus Entry Opportunities

Entrants may earn additional entries by completing optional activities:

Limit five (5) entries per activity, for a maximum of twenty-five (25) bonus entries per entrant.

All entries must be received during the Sweepstakes Period. Mechanically reproduced, incomplete, illegible, or late entries will be void.

Sponsor is not responsible for lost, late, misdirected, or undelivered entries.

Entrants must provide accurate contact information. By entering, entrants grant Sponsor permission to use their name, likeness, voice, and photograph for promotional purposes where permitted by law.

This promotion is in no way sponsored, endorsed, administered by, or associated with Facebook, Instagram, YouTube, X or TikTok. Entrants release these platforms from any liability related to this Sweepstakes.

6. PRIZE

One (1) prize will be awarded: a 2025 Porsche Macan (VIN: WP1AA2A5XSLB11999) (the “Prize”), with an approximate retail value (ARV) of \$70,603.40.

The winner may elect to receive either:

- The vehicle described above, **or**
- A cash alternative of \$25,000

The winner may not receive both.

The Prize is awarded “AS IS” with no warranties, express or implied, including but not limited to implied warranties of merchantability or fitness for a particular purpose, except for any applicable manufacturer’s warranty.

The vehicle may have accumulated mileage due to promotional use. Exact mileage will vary.

If the vehicle is selected, the winner is responsible for all costs associated with ownership, including but not limited to taxes, title, licensing, registration, and insurance.

7. SWEEPSTAKES ODDS

The odds of being selected as a finalist and ultimately as the winner depend on the total number of eligible entries received.

8. PRIZE DRAWING

The winner of the Prize will be determined at a to-be-announced event hosted by the Sponsor (the “Event”). Time and location of the Event will be announced at a later date. Prior to the Event, the Sponsor will randomly select nine finalists from all the eligible entries to take part in a random key draw at the Event to win the Prize. Selection of the finalists will take place on or around September 3rd, 2026 at which time selected finalists will be contacted. The finalists’ names will then be posted on or around September 21st, 2026 (allowing time to confirm finalists). All finalists must be present at the Event to participate in the random key draw to determine the winner of the Prize. The tenth finalist will be drawn at the event.

9. WINNER NOTIFICATION

The nine pre-event finalists will be randomly selected by Sponsor and contacted on or around September 3rd, 2026. The potential finalists will be notified via phone using the contact information provided at the time of entry. The potential finalists must respond to the notification within 72 hours of notification and will be required to provide proof of residency of the State of Iowa, signed Photo Authorization Form and any necessary tax information. If the potential finalist fails to respond within the required timeframe, is found ineligible, or fails to return the completed documents within the specified time, they may be disqualified, and an alternate finalist will be randomly selected at Sponsor’s sole discretion.

The winner, who will be determined at the Event, will have until the close of business two weeks following the event, to claim the Prize. If the Prize is not claimed, the Sponsor shall donate the unclaimed Prize for educational, civic, public, charitable, patriotic, or religious use.

The winner will be required to sign a release form in order to claim the Prize, and also provide the Sponsor with a signed statement confirming his or her eligibility under these Rules and applicable law, plus a valid Iowa driver’s license and social security number. By claiming the Prize and signing the release form, the winner release the Sponsor, their officers, directors, members, employees, subsidiaries and affiliates from any and all claims, liabilities, and/or damages arising directly or indirectly out of the award and/or use of the Prize. The Sponsor is not responsible for illness, death or injury which may be sustained in conjunction with participation in the Sweepstakes and/or the use of the Prize awarded.

The Sponsor is not responsible for any incorrect or invalid contact information, undeliverable messages, or technical issues that may prevent successful notification.

10. GENERAL CONDITIONS

In the event that the operation, security, or administration of the Sweepstakes is impaired in any way for any reason, including but not limited to fraud or unauthorized human intervention or other technical problems, or in the event that the Sweepstakes is unable to run as planned for any other reason, as determined by the Sponsor in their sole discretion, the Sponsor may, in their sole discretion, either a) suspend the Sweepstakes to address the impairment and then resume the Sweepstakes in a manner that best conforms to the spirit of these Official Rules or b) award the Prize at random from among the eligible, non-suspect entries received up to the time of the impairment. The Sponsor reserves the right at their sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the legitimate operation of the Sweepstakes. Such activities may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorney fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision. Decisions of the Sponsor are final.

11. RELEASE AND LIMITATIONS OF LIABILITY

This includes but is not limited to:

- a) Technical errors associated with the Sweepstakes, such as lost, interrupted, or unavailable Internet Service Provider (ISP) access, or network, server, wireless service provider, or related connection errors. Said technical errors may also include the unavailability, limited accessibility, or miscommunication of a failed computer, satellite, telephone, cellular tower, or cable transmission line, or a technical failure or jumbled, scrambled, delayed, or misdirected transmission or computer hardware or software malfunction, or failure;
- b) Unauthorized human intervention in the Sweepstakes;
- c) Mechanical, electronic, human, and printing and/or typographical errors;
- d) Application downloads and/or failures;
- e) Any other errors or problems pertaining to the Sweepstakes, including, without limitation, errors that may occur in the administration of the Sweepstakes, the announcement of the winner, the cancellation or postponement of the event, or the incorrect downloading and processing of entries or any Sweepstakes-related materials;
- f) Injury, death, loss, or damage of any kind, to persons and/or property which may be caused, directly or indirectly, in whole or in part, from the entrant’s participation in the Sweepstakes or acceptance, receipt, or misuse of the Prize (including any travel or activity related thereto). Entrant further agrees that in any cause of action, the Released Parties’ liability will be limited to the cost of entering and participating in the Sweepstakes, and in no event shall the entrant be entitled to receive attorney’s fees; and/or
- g) Incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Sweepstakes. Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

12. DISPUTES

Except where prohibited, each entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the courts of Polk County, Iowa. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrant’s rights and obligations, or the rights and obligations of the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Iowa, without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than Iowa.

13. LEGAL PROCESS

In the event that the Prize winner is subject to, or the subject of, any order or legal process issued by any governmental agency having jurisdiction over the affairs of the winner (e.g., garnishment, child support order, judgment, lien, and the like) the Sponsor’s delivery of the Prize to an official representative of the governmental entity claiming a right to the Prize shall be deemed to be the award of the Prize to the winner. The Sponsor shall be entitled to rely in good faith upon any documents presented by the representatives seeking to collect the Prize in lieu of the winner. The Sponsor shall not be liable for any claim by winner for damages incidental thereto.

14. FINANCIAL OBLIGATION

The winner assumes the financial obligation for local, state and federal taxes and all applicable fees based on the value of the Prize. In accordance with IRS regulations, the winner will be sent an IRS Form 1099. For additional information, please consult with your tax advisor.
